

Kellogg Croke Park Dunnes Stores Promotion Long Terms and Conditions

1. The Promotion is open only to residents of the Republic of Ireland over the age of 18.
2. Promotion is not open to employees of the Promoter or any member of their immediate families (defined as parents, siblings, children & spouse regardless of where they live), any participating stores, affiliated companies, agents or anyone professionally connected with the Promotion.
3. By taking part in this promotion individuals will be deemed to have read and understood these terms and conditions and be bound by them.
4. By entering this promotion you confirm that you are not breaching any laws regarding the legality of entering. The Promoter will not be held responsible for any entrant entering the promotion unlawfully.
5. The promotional period is from 18.04.23 to 15.05.23 and is open 9am-9pm daily.

Data Protection Statement 90 days

This statement describes how we use your personal information in connection with this Promotion. Please take time to read it carefully. The Data Controller is Kellogg Company of Ireland, Dublin Airport, Block 3, Swords, Dublin. (Same here on Data controller)

The personal information collected by us includes your name, phone number, email address and any other details furnished by you in entering the Promotion. If you are awarded a prize we may contact you for more information such as your home address to administer or deliver that prize.

We will not use the personal information provided for direct marketing, or provide it to any other organisation for that purpose.

1. The purpose and legal basis for processing your information

Any personal data submitted will be processed in accordance with data protection law. We will only use your personal data with your consent.

2. Your Information and Third Parties

Third Party Service Providers: We may share your personal information with third party service providers that perform services and functions associated with the Promotion at our discretion and on our behalf such as our marketing company, prize fulfilment agency, IT service providers, lawyers and other business advisors and other providers of security and administration services. We will ensure that any third party operates strictly under a contract and will keep your data safe and secure.

An Gardaí, Government Bodies or officials: We may share your personal information with and Gardaí or other government bodies or agencies where required to do so by law.

3. Storage Periods

We will hold your data for approximately 90 days beyond the termination of the Promotion for the purposes of reporting and responding to queries. Details of prize winners will be held in accordance with our legal and record-keeping obligations.

4. Your rights

You have the right to withdraw your consent at any time.

You also have several rights under data protection law in relation to how we use your personal information. You have the right, free of charge to:

1. Check what type of personal data we hold about you and what we do with that information. You are also entitled to receive a copy of this information.
2. Rectify any inaccurate personal information we hold about you
3. Erase personal information we hold about you
4. Stop us from using your personal information in certain cases, including if you believe that the personal information we hold about you is inaccurate or our use of your information is unlawful. If you exercise this right, we will store your personal information and will not carry out any other processing until the issue is resolved.
5. Object to us using your personal information where we rely on our legitimate interests to use your information. We will stop using your personal information unless we can demonstrate overriding legitimate grounds for the continued processing of this information; and
6. Receive your personal information in a structured, commonly used and machine readable format and to have that data transmitted to another data controller.
