- b. Using a smartphone, visit [www.kelloggs.com/pokemon](http://www.kelloggs.com/pokemon) (or navigate to the Pokémon experience) and sign into their Kellogg's account or register for one for free and complete the multi-factor authentication requirements if prompted to;
- c. Enter the last four digits of the on-pack barcode;
- d. Click "Play Now" and
- e. Complete the challenge ("the challenge") in the fastest time.

## 6. Further Entry Conditions:

- a. Smart phones using operating systems below iOS 14 or Android 9, and iPhone models older than an iPhone 8 may operate at a sub-standard rate which may impact on an entrant's completion time.
